The Clause no. 1.5 (EMD) under Section-I of this office Tender Call Notice No. BHEP/28/ 2025-26 Dtd. 04.08.2025 for the work "Supply, Installation, Commissioning & Demonstration of Portable Dissolved Gas Analyzer with Standard Accessories & Transit Case" is hereby partially modified as per office memorandum No.4281/W/07559600052021 dated 05.03.2025 of Works Department, Govt. of Odisha i.e. "The exemption from deposit of Bid Security/EMD at the time of participation in tender & concessional payment of Performance Security @25% of the value of Performance Security to Local Micro 7 Small Enterprises (MSEs) and Starts-up as extended vide this Department O.M No. 503/W dt 17.01.2022 will no more exist w.e.f the date of issue of the office memorandum." The detailed of partially modification is given below;

1.5 EMD:

- The tenderers are required to deposit an amount equivalent to **1% of quoted value** (exclusive of GST) towards EMD (**refundable**) in the shape of **D.D** from any nationalized Bank / Scheduled Bank drawn in favour of Orissa Hydro Power Corporation Ltd. Payable at SBI, ORKEL Branch, Balimela along with the Tender document, failing which the tender will be **out rightly rejected**.
- The EMD amount will not carry any interest. The EMD of unsuccessful bidders will be returned after finalization of Tender and that of successful bidder will be returned after acceptance of order & submission of security deposit.




