OFFICE ORDER

In pursuance of the Finance Deptt. Office Memorandum No.Pen-74/2019/8286/F dtd.07.03.2019, the management is pleased to sanction one additional dose of Dearness Relief (T.I) @ 3% in the revised scale of pay in favour of the pensioner / family pensioner of OHPC w.e.f 01.01.2019.

Accordingly, it has been decided to enhance the Dearness Relief (T.I) @ 3% w.e.f 01.01.2019 in the revised pension / family pension. With this additional dose of Dearness Relief (T.I), the T.I now payable on the revised basic pension / family pension will be enhanced from 9% to 12% w.e.f 01.01.2019. The T.I payable in accordance with this office order shall be drawn in cash alongwith the pension of March,2019 payable in April,2019 & onwards. The arrear T.I from 01.01.2019 to 28.02.2019 at the enhanced rate as applicable shall also be drawn in cash and disbursed after payment of pension of March,2019.


