NOTIFICATION

Sub: Amendment to uniform Pension Scheme-2012.

Pursuant to the decision of the Board of Directors of OHPC in their 121st Meeting held on 10.06.2014 & subsequent approval of Govt. of Odisha, Department of Energy vide their letter No. 9409 dtd.18.11.2015, **the existing Clause 5 (i) i.e. Benefit under the Pensionary Scheme for Non-pensionary Category Regular Employees of OHPC, 2012** notified vide Notification No.7692 dtd.06.09.2012 of OHPC has been replaced as follows:

“The rules and procedures of OCS (Pension) Rules with regard to minimum years of service of 10 (ten) years, commutation of pension, family pension, TI etc. shall be the same. The amount of pension with Temporary Increase (TI), shall be reduced by the amount of pension due from RPFC from the Gross Pension”.

However, the financial benefits accruing on account of Temporary Increase (TI) to the pensioners covered under the OHPC Uniform Pensionary Benefit Scheme, 2012 shall be applicable w.e.f. 01.11.2015 onwards and no arrears up to 31.10.2015 on this account shall be paid.

All other terms and conditions of said Notification No.7692 dtd.06.09.2012 shall remain unchanged.
