It is notified that, all the Pension holders getting Pension from OHPC Pension Fund Trust during F.Y. 2019-20 (A.Y.2020-21) are requested to download the 12BB form from the official website of OHPC i.e., <http://www.ohpccltd.com> and submit the same to OHPC Pension Fund Trust duly filled-up & signed along with copy of their **PAN Card & Adhar Card** (if not submitted in the earlier year) latest by 31-07-19. In case a pension holder has not deposited the requisite savings (U/S 80C-80U) by 31st July & want to deposit the same at a later date he can submit the undertaking with the proposed amount to be deposited & the expected date of deposit. Failing the above compliance, the TDS will be deducted as per IT rule Considering their pension drawn from every month starting from August 2019 expected to be drawn at this end during the Financial Year 2019-20 proportionately.

The family pension holders are not required to comply the above. They however advised to submit the copy of Adhar Card.
