In partial modification to TCN No.05/2025-26 Dated 11.04.2025, the service charge mentioned in the Serial no. 04 of page no. 25 of price bid under Part – VI(Bidders quoting service charge less than 5% of the rate of the per man month shall be rejected.While evaluating the bid lowest price up to two decimals shall only be considered for all purposes, ignoring further decimals if any quoted by the bidder) is changed as follows :

“The minimum service charge will be 3.85%(3% profit plus transaction charge). The procuring entity can also fix the service charge above 3.85% with proper justification, whenever required. However such charge should not exceed 7% in any case. Otherwise the bid(s) will be rejected. GST as applicable will be paid/reimbursed as the case may be”. The quoted rate of service charge should include the cost of Uniform etc. to be provided to the manpower engaged.

All other terms & conditions of the Tender remain unchanged.
